- B. When your wife has sinned against you, how do you approach that? What do you say? How do you and she know it's resolved?
- C. What are good things that come from devotions between husband and wife? How do you start?
- D. Jesus lived a perfect life which is now ours by faith and fulfills God's demands under the Law. Jesus took the punishment for our sins on the cross. Why is marriage a primary place to apply these precious truths?

 - What is one practical application or how does/could/should that work in your home?
 - When or how can “service to others” become a problem or lead to a loss of balance? How does a Christian maintain a god-pleasing balance?

- H. How do you strike a god-pleasing balance?
- I. The speaker raises the question, “Did you do all you could do to bring your wife and children into God’s presence? How do you answer that question?”
